

Citizenship in Europe at a turning point – Consequences to international family law and registrar's work

The first day of the 16th EVS congress, takes place together with the congress of the Flemish Association of Registrars, and focuses on citizenship. Nationality law changed thoroughly in many European countries in recent years. More and more states accept the dual or multiple nationality of their citizens. The growing international mobility of citizens and migration are closely related to this situation. Citizenship is less then it used to be a criterion for professional and social life. Not possessing the nationality of the country where you reside can, however, still cause specific problems.

Conditions for acquiring the citizenship are often made more strict. The citizenship as a "personal statute" stays on the European Continent the main connecting factor to determine family law related issues as maternity and paternity, marriage, name law etc. Conflicts of laws due to dual nationality have different solutions in different states. The jurisprudence of the European Court in Luxemburg sees this as a treat to the free movement of EU-citizens.

The European citizenship, established through the nationality of each EU member state, grows in importance. The EU interferes more and more in the field of family law and the registration of life events. The European Association of Registrars (EVS) wants to contribute to truly European solutions in the best interest of all of our citizens who are entitled to have the same name and family relations in the whole of Europe.
